FEE SCHEDULE

For professional services provided by Elise P. Salerno, M.D., C.L.C.P.

Fees for Services

▶ **Retainer**

A \$3,000 nonrefundable deposit per case must be received before work will begin.
The retainer will be applied to charges for services rendered.

▶ **Life Care Plan**

\$12,000 per person evaluated + expenses (listed below)
Rate is the same for plaintiff, defense, and 3rd party life care plans and includes case review and assessment, research, generation of written report(s), plan development, testimony preparation, and related services for up to 45 hours of work. All hours worked beyond this will be billed at the Professional Assessment rate listed below.

▶ **Professional Assessment**

\$300/hour + expenses (listed below)
Consultation without request for creation of a life care plan includes case review and assessment, research, generation of written report(s) or commentary, testimony preparation, and related services.

▶ **Expert Testimony**

\$2,500 per calendar day
+ lodging and transportation expenses (when applicable)
This includes any travel time on that day.

▶ **Travel Time**

\$1,250 per calendar day
+ lodging and transportation expenses (when applicable)

▶ **Accelerated Rate**

Fees equaling 150% of those listed above for Life Care Plan and Professional Assessment will apply when requesting:

- Testimony within 60 days from date of referral and/or
- Written report within 45 days from date of referral and/or
- Completed Professional Assessment within 45 days from date of referral.

▶ **Expenses**

Actual incurred expenses will be billed at cost for items including but not limited to copyright fees for peer-reviewed journal articles supporting items in the Life Care Plan or Professional Assessment, printing and copying, economy class air travel, ground transportation, vehicle rental fees, and lodging.
